This coming Friday, September 29th, we're having an important conversation here at Harper. I bet that you're all aware that we've been looking at the Town Charter, a set of codes guiding how Williamstown works, to see if there are any areas which need to change or be updated. A good example of this would be from Town Meeting last May when we voted to strike the provision requiring the Town Manager to reside in Williamstown. I can't actually tell you when this document was revised last, I know that it wasn't recently but we're looking at it now.

On Friday at 1:00 Selectors Jeff Johnson and Randy Fippinger will be in the house to talk with everyone about the process and look for your thoughts. They'll have materials to share, actually I have attached links to two pertinent links to the email, some slides with charts you may have seen at National Nite Out and the interim report on the process so far. There will be a limited number of paper copies available on the day. We'll provide refreshments. All are invited. We'll also have a few Chromebooks available for individuals who might like to do the Charter survey while they're here, just in case you're interested.

Some folks out there have collided with scheduling at the Registry of Motor Vehicles. The RMV say they provide appointments at (most) Service Center Locations during any available time Monday through Friday between 9:00 a.m. and 5:00 p.m. dedicated to customers over the age of 65 and people with disabilities. An appointment is required to visit to conduct License or ID related transactions.

There are registration-related transactions can be performed at an RMV Service Center without an appointment. Examples of Registration transactions include registering a vehicle; transferring vehicle to surviving spouse; amending a registration; reinstating a registration; and confirming identity for a registration renewal. Customers who are at least 65 years of age or have a disability can call the RMV's dedicated appointment line at 857-368-8005 to schedule a license or ID appointment. The RMV's Senior License Renewal Appointment Line warns customers that they will not be served if do not meet the above qualifications.
